

## TEMPLE DAVID - JEAN SHUMAN MEMORIAL COLLEGE SCHOLARSHIP

### GUIDELINES

Rabbi Robert Jacobs will direct the Shuman Scholarship program for the school year 2025-2026.

1. The applicant must be Jewish, a Confirmand, and a member in good standing of Temple David.
2. A financial need will have to be established. While this does not necessitate that income tax form 1040 be submitted with the application, if circumstances warrant it, such tax information can be required before the scholarship is granted.
3. An **official** transcript of current academic performance is to be submitted with the application. The applicant may already be attending college or have been admitted to a college undergraduate or graduate program. Religious School performance and continued involvement in Temple David may also be taken into account.
4. The applicant understands that a personal interview is a mandatory part of the application process.
5. The scholarship is granted once a year however an applicant who receives such a scholarship may apply in a subsequent year. In addition, applicants who may not have qualified in one year may reapply in the future if circumstances warrant.
6. A completed application including the official transcript must be received by the Temple office by **Friday, March 14, 2025** at which time interviews will be scheduled.
7. The scholarship award at this time is \$5,000.00.
8. It is expected that the winner of the scholarship will make every effort to attend the Temple David Annual Meeting on **Wednesday, May 7, 2025** when the scholarship recipient is announced as well as promptly write a letter of appreciation to the donor family.
